## Patricia Menton opens 'The Case of Emil Diesel'

Max Diesel fights the East Germans and present-day Germany to reclaim his father's precious art collection

LYNN, Mass. – For 10 years, Patricia Menton listened to her husband's stories about his father and became part of his adventure while taking notes along the way. Realizing the story about the case had to be told in fiction, she penned "The Case of Emil Diesel" (published by Xlibris). Inspired by real-life events, the novel is about art theft blended with twist and turns of intrigue, suspense and emotional drama. When Max returns in 1975, after his father's untimely death to claim his rightful inheritance, he is coerced into a conspiracy to regain possession of his art, but not without repercussions, until 2013, when he struggles with the city and the museums in Germany for his inheritance which leads to a riveting conclusion.

Menton relates the book to the ongoing cases of people today trying to reclaim art that was rightfully theirs from museums. As it is themed with how one faces life's conflicts in the pursuit for art, the book highlights how one fights for truth and justice when one is up against greater powers all in the name of art.

"I want (the readers) to really enjoy the story and realize that fighting for what you believe is everyone's right," Menton concludes.
